The Burlington Town Council held a regular monthly meeting on Tuesday, March 9, 2021 at 7:00 p.m. at Town Hall with Council's Kevin Hammond and Jim Enoch; Clerk-Treasurer Karen Dinger; Town Marshal Terry Moore and Public Works Commissioner Steve Stout present.
